

**SECURITY BULLETIN****SB 2020-13****July 04, 2020****SUBJECT: Amendment to SECURITY MANUAL edition 4.0, April 2017**

Effective with immediate effect	Addition to Security Manual edition 4.0 Health measures applicable to Aruba operations I. APPLICABILITY This Security Bulletin contain CoVID-19 related measures as indicated by the Government of Aruba, applicable to all flights bound to Aruba. II. PASSENGER REQUIREMENTS (A) COVID-19 Health Insurance Every individual passenger shall arrange a valid Covid-19 health insurance that covers their stay in Aruba. Persons exempt from the COVID-19 Health Insurance requirements are: — Crewmembers; — Residents of Aruba, Bonaire and Curacao; — Students of Aruba; — Children under the age of 15, but are required to pay a one-time fee; — Transit passengers not entering Aruba; — Diplomatic Officers visiting Aruba for their work; — Dutch Military Personnel, including his or her spouse and children. (B) COVID-19 PCR Test Passengers shall either: a. Being able to present certification of a COVID-19 PCR test to local Aruban (health) authorities upon arrival, which must have been performed within 72 hours prior to departure, certifying a negative outcome. Those passengers are subject to medical screening upon arrival in Aruba, consisting of temperature reading and an interview performed by local (health) authorities; or

- b. Being subject to a COVID-19 PCR test upon arrival at his or her own expense, combined with a one-day self-quarantine requirement while he or she awaits the test result.

Persons exempt from the COVID-19 PCR test requirement are:

- Crewmembers;
- Children under the age of 15;
- Transit passengers not entering Aruba.

(C) Online Health Assessment

Every individual passenger is required to complete an online health questionnaire within 72 hours prior to boarding any flight bound to Aruba. This health Assessment should result in an "OK to board" statement, which shall be presented to KLM Royal Dutch Airlines ground staff before being permitted to board the respective flight bound to Aruba. The respective Assessment is available on www.edcardaruba.aw.

Persons exempt from the COVID-19 PCR test requirement are:

- Crewmembers;
- Transit passengers not entering Aruba.

III. REFUSE TO BOARD

Those passenger who are not able to present an "OK to board" statement during check-in or at the respective boarding gate, shall not be permitted to board any flight bound to Aruba. The "OK to board" statement shall not be collected by ground staff and must remain with the passenger.

IV. PUBLIC HEALTH LOCATOR FORM

Every individual passenger shall complete a Public Health Locator Form, in the event a positive COVID-19 case on board the aircraft has been detected.

**SECURITY BULLETIN****SB 2020-13****July 04, 2020****V. CREWMEMBER REQUIREMENTS****(A) General Declaration**

The Commander of the flight shall complete the Health part of the General Declaration form and shall arrange to submit this form to the Aruban Immigration Officer at the airport for inspection.

(B) COVID-19 Status Card

In case of disembarking crewmembers in Aruba, the Crew COVID-19 Status Card shall be completed and submitted to the Point of Entry Healthcare Worker upon arrival.

(C) Health Screening of Crewmembers

Crewmembers entering Aruba are subject to medical screening performed by local (health) authorities, consisting of temperature reading and an interview.

In the event a crewmember shows any symptom that may indicate a COVID-19 infection, or the measured body temperature indicates a fever during health screening upon arrival, than the respective crewmember shall travel back to the Netherlands as dead heading crew, on the same aircraft where that crewmember arrived on in Aruba. This requirement is based on an approved alternative procedure request, preventing a crewmember from being COVID-19 PCR tested and being held in quarantine consequently.

VI. EASA COVID-19 HEALTH SAFETY PROTOCOL

In addition to the requirements as laid down in this Security Bulletin, all flights to and from Aruba shall comply with the EASA COVID-19 Health Safety Protocol.
