#### Description

Dear colleagues, In (10)(2a), any vaccine which is given as part of the National Vaccination Programme by law needs to be noted down in the patient medical e-files (person identifiers, name of vaccine, lot #, when given). Our expectation is that the SARS-CoV-2 vaccine will be defined as part of the NVP. These vaccination data elements are then transferred almost real time to the National Vaccination register, and can be used to monitor coverage as well as via register linkage by the individual person identification code to study vaccine impact, both effectiveness and safety.
