Objet : AZ vaccine re-allocation ("Bazaar" process)

Dear all,

This email concerns the "Bazaar" business between MS, in full transparency in front of the Commission, where we re-allocate doses to pragmatically balance our pro rata purchase obligations vis-a-vis the wishes by MS to buy more or less of the vaccine.

As mentioned on the phone yesterday:

We all agreed to forego 3% of doses to EEA and CH ([REDACTED] 5.1.1c doses). The allocation table (B-table) began with a pro-rata distribution of available doses minus the 3%.

Thereafter, two MS indicated they wanted less (CZ and PO) and two MS that they wanted more (EE, MT). After this exercise we have a surplus of almost [REDACTED] 5.1.1c doses.

This means we can adjust the allocations and MS can go back close to the original dose allocation (before the 3% deduction). Please find attached the new proposed allocation table. There is a remaining surplus of 800K doses that will be absorbed by DE and SE.

**Question to all MS except CZ, EE, MT, PL:** Please let me know (with [REDACTED] 5.1.2e in copy) by **COB Wednesday Sept 16** if you say **YES** to the new allocation (column F; almost the same as the original allocation) or **NO** if you prefer the previous reduced doses in column C (-3%).

I know some of you (like NL I believe) are already locked into the previous allocation (-3%) through your budget procedures.

If the end result is that there is still a surplus, it will be absorbed by a few MS.
