Dear 5.1.2.e,

I received your contact information from 5.1.2.e of the Dutch State Department. I work at the Interior Department of the Dutch Government. One of the topics I work on is disinformation policy.

During the COVID-19-crisis we have been in contact with several tech companies about their disinformation policy and other measures taken in the past month. These regular contacts have allowed us to stay up to date on developments and reach out to companies when necessary.

Up until now we have not been in contact with Reddit, also not about the COVID-19-crisis and the effect it has on the spread of (dis-)information online.
