Hi 5.1.2.e,

Thanks for supplying the email addresses.

Your question is valid and we have been thinking how to best organize the discussion, especially since it will also be held digitally. One thing we want to prevent is that only lengthy introductions are made of everyone's viewpoint and that this leaves no room for discussion. Therefore, our preference is that viewpoints are shared as much as possible per topic to facilitate a more interactive conversation. Of course each company will make some sort of introduction, but we would like to urge you to not thoroughly address everything your company has done and will do against disinformation in your introduction.

In order to facilitate a more active discussion I think it also makes sense to change the order of the talking points so that the discussion is first about the most current topic, then what has already been done about disinformation and then moves towards future expectations. The talking points would then be in this order:

1. Dis- and misinformation during Covid-19
2. Fighting dis- and misinformation, and the role of tech companies in it
3. Transparency on dis- and misinformation policy and measures
4. Regulation and the Democracy Action Plan

This is how we think we can best organize the discussion around these topics. If you have any objections against it, feel free to let me know. We also still have to discuss the preparation and the dossier with the Minister's office, which may also lead to some changes in the approach. If that happens I will let you know.

We have consulted with the Minister's office again and their new proposal is a meeting of 45 minutes on the 25<sup>th</sup> of June from 13.00-13.45. Due to her busy schedule until parliament's summer recess on the 7<sup>th</sup> of July this was the maximum time that could be made available.

As stated before, we believe that if we brief the Minister well on recent developments and each of your companies' policies (possibly aided by factsheets from your side) that we can have a meaningful discussion and exchange of views, even with limited time. Nonetheless, the meeting can only be successful if all parties support the plan.
