To our conversation just now, having consulted w/ our legal counsel: SYNLAB can agree to proceed with the live testing tomorrow on the basis that parties are in agreement on most of the outstanding points of the draft contract as shared by us this morning. For the sake of clarity, until the contract is duly signed by both parties, the limitation of liability clause as per our latest draft will be applicable together with the MOU.

Separately and in connection with this morning's media enquiry directed at us in NL, but also in anticipation of next week, we would like if possible to achieve alignment on communication. I would like to facilitate for an exchange between the person responsible for external communication on this project at VWS and my colleague [REDACTED] in cc' who is in charge of group communications at SYNLAB. Do you think that this would be possible, perhaps already tomorrow if signing is to take place on Monday?
