 - From 2 November 2020 to 29 November 2020: test volume provided 6000 test/day; guaranteed purchase volume 2.400 tests / day (40%)
 - From 30 November 2020 until 31 December 2020: test volume provided 12.000 tests/day; guaranteed purchase volume 4.200 tests /day (35%), ramping up to 25.000 tests/day before year-end (guaranteed purchase volume 8.750 test / day (35%))
 - From 1 January 2021 to end of contract term: test volume provided 25.000 tests/day; guaranteed purchase volume 8.750 test / day (35%)

Address: [Groenewoudseweg 275](#), Nijmegen

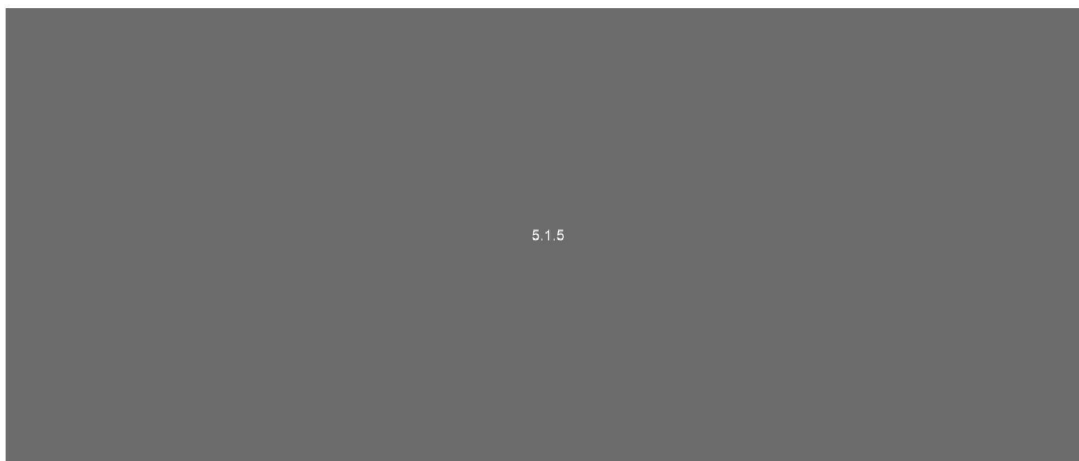

2. GGD Gelderland-Midden, test location Arnhem "Gelredome" (near the 'Vitesse' soccer stadium)

Route description: Drive onto the Gelredome stadium (on the right you see McDonalds). Turn left before the stadium and follow the signs to "Supportershome Monnikenhuize".
