Dag collega's,

Bijgaand een document van de ECDC over "Considerations in prioritizing access to COVID-19 vaccines in EU/EEA Member states".

"Please provide an opinion on the prioritisation of delivery of COVID-19 vaccines (i.e. identification of risk groups, priority groups for vaccination, and settings for vaccination) **considering all relevant parameters** such as for example: hospital admissions, demographic structure, models in case 1, 2 or more vaccines would be available but the availability would be spread over several months, needs for booster doses etc. ECDC should make a suggestion which parameters should be considered and prioritized to help the development of a framework at EU level for COVID-19 vaccination plans. The draft outcome document will be sent to the HSC for discussion and comments. The final version will serve as an input to the forthcoming immunization plan, currently being prepared by the EC."

This request follows a Health Ministerial meeting held on the 7th of May that expressed strong support for mandating the Health Security Committee to prepare an EU vaccination plan, for possible joint procurement of vaccines, and for the Commission to explore the use of the Emergency Support Instrument for increasing production capacity and support availability of COVID-19 vaccines. Further, the importance of securing **equitable access** to the vaccines for all Europeans was mentioned and a number of countries supported the idea that the Commission should explore using the Emergency Support Instrument (ESI) for liability insurance."
