Dear all,

We are very pleased to be reaching out to you regarding the H2020 call on "[Behavioural, social and economic impacts of the outbreak response](#)". EuroHealthNet is coordinating a response to the call, and we are delighted to have the opportunity to work with all of you on it. You will find below more details on where we currently stand, as well as the next steps. Given the extremely tight deadline, we are counting on your quick responses in the coming two weeks to enable us to submit a high-quality bid on time.

#### **Confidentiality**

As this bid is likely to be highly competitive, we would kindly ask you to keep all documents pertaining to this consortium **strictly confidential**. We are presuming that all partners are not taking part in any separate consortiums - should this not be the case, we kindly ask you to let us know.

#### **Draft proposal**

You will find attached here a draft outline of the different WPs, which seeks to integrate the thoughts we have received from different partners up until now. The draft also includes a preliminary list of partners, although we are also in touch with others, pending confirmation. Your further comments on this draft would be welcome. At this stage we can still change the structure and content of work packages if needed. We kindly ask for your **feedback by COB tomorrow, 28 May**. Alongside general comments, we would also ask you to let us know the following:

- Whether you would be interested in implementing and ideally also evaluating a "best 'next' practice" (as part of WP6) - for the implementation, you could also work with a partner on the ground
- Whether you are interested in leading a specific WP, or a task within a WP. Although we will do our best to accommodate

all requests, kindly note that in some cases this will not be possible. Please note that all WP leads will be asked to draft their WPs, describe research methodology in detail, indicate deliverables and timeline.

Once we have received and reviewed all input we will get back to you (ideally by **Friday 29 May**), to confirm WP leads, asking you to draft the respective WPs, by **Wednesday 3 June**. Of course, we will also provide input and feedback during this process.

#### **Administrative and budgetary issues**

You will find attached to this email three forms, which we kindly ask you to fill in for the indicated deadlines. These will allow us to proceed with necessary administrative and budgetary issues, as well as Section 4 of the proposal (partner information and relevance to the bid). As soon as we have more clarity on the final list of partners and breakdown of WPs, we will engage in further discussions on the budget.
