Seroepi contact points nominated separately to ECDC

- SeroEpi 2 – List of EU/EEA designated experts to ECDC

- For this list it is not possible for me to filter out "lab" contacts from "epi" contacts in this list.
 - Please consider still to include these in the invite but to specify in it that the project is only valid for laboratories. Perhaps this is an obvious point, but it would be good to apologize for spamming the other contacts.

Please note that I have indicated in red colour duplicate institute names, so you should count those institutes only once.
