You will understand that this is not common procedure and can lead to problems in the warehouse.

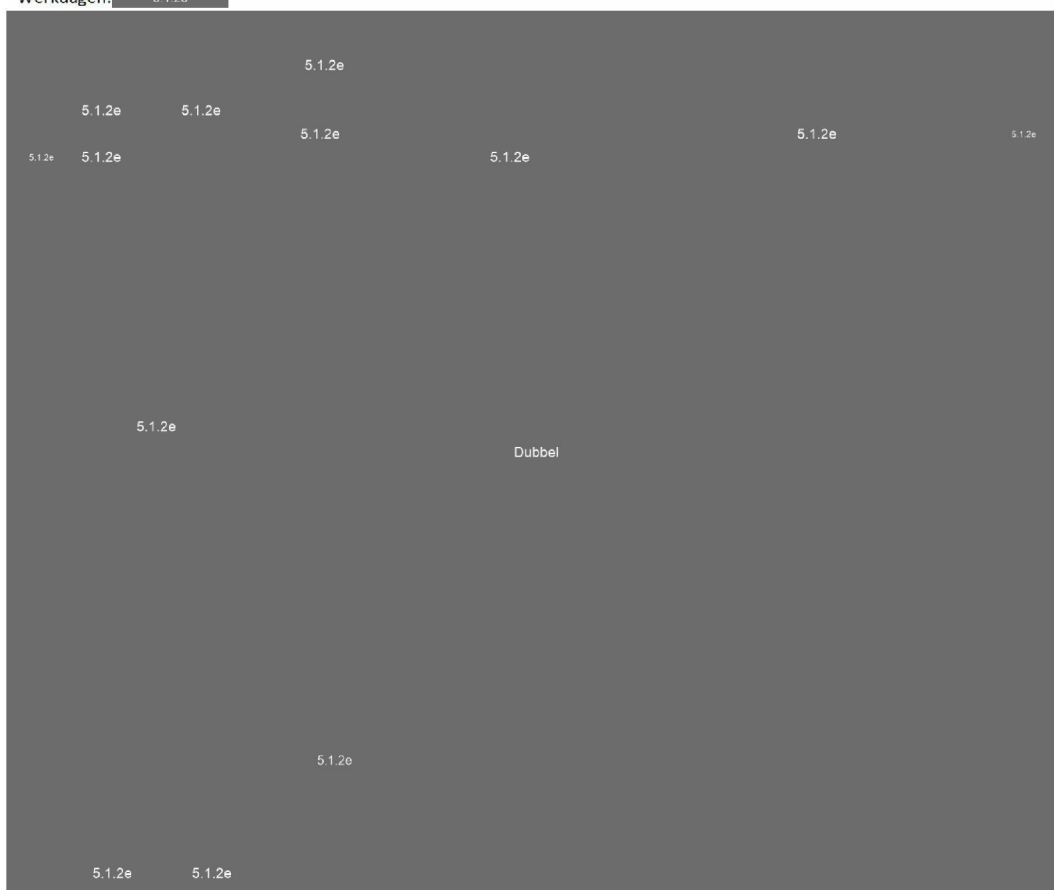
