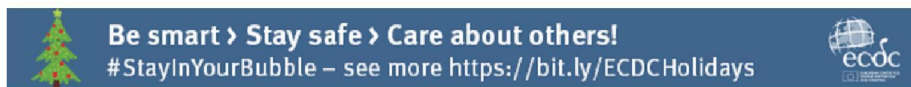
Hi,
