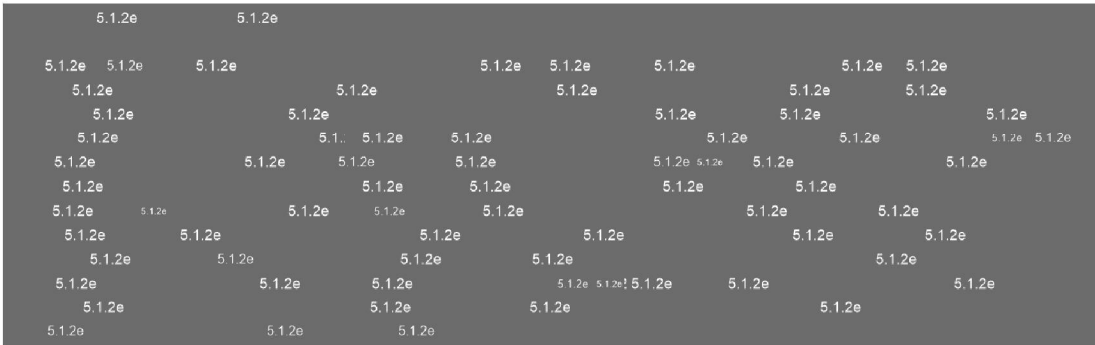


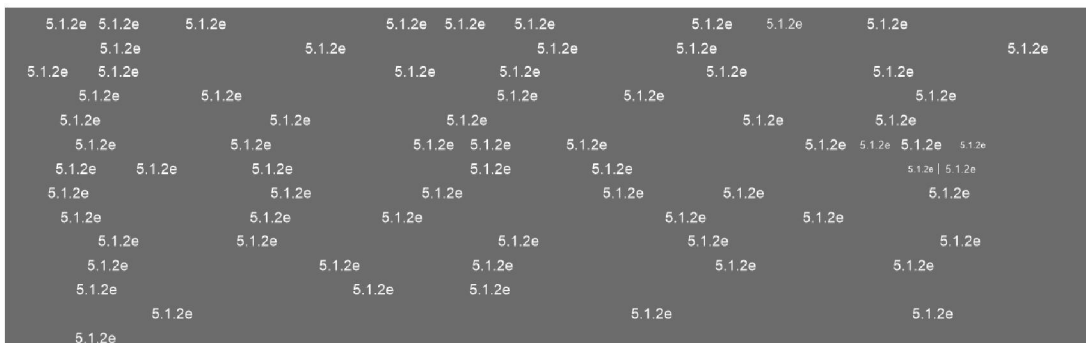

thank you for ECDC continuous effort on uptating and enriching RRA

My comment regards the "Figure 5. Change in 14-day incidence of reported COVID-19 cases/100 000 population in EU/EEA countries and the UK at subnational level between weeks 29/30 and weeks 30/31".
In fact, with small numbers (often the case of small sub-country level area) the criteria of relative rate changes (cases: >10%) for considering increasing/decreasing trend can be very sensitive and the area can "lights up" easily.
As map publicly available, this can be misunderstood as a clear indication for not going into that area because at risk, while the number are very small as well as the real risk.
I am not sure if it is possible to explain it in the text or to avoid doing below a certain level of incidence.

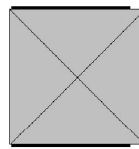
