Dear colleagues,

Thank you very much for the email.

In general in the Netherlands we test patients who are symptomatic with PCR method. The CT value is not always available, depending on the laboratory. We do not routinely re-test after an initial positive test. Whole genome sequencing is only done in special cases, e.g. in the investigation of clusters.

This is all the information we have available, at the national level we do not have personalized information on all COVID-19 cases in the Netherlands.

Please let us know if and why you need more information.

The New Zealand National Focal Point have been informed of a case of COVID-19 in the Netherlands who has recently been in New Zealand.

Situation Summary

One of our local public health units has been contacted by a couple living in Port Waikato who say they are contacts of two Dutch tourists who have recently left NZ (on [REDACTED] 5.1.2e), one of whom has tested positive for covid on arrival home in the Netherlands.

The details provided to us on the Dutch tourists are:

- In NZ since [REDACTED] 5.1.2e Port Waikato on the [REDACTED] 5.1.2e Flew out of NZ via Auckland on the [REDACTED] 5.1.2e transit via Singapore to Netherlands.
- The male tested on the [REDACTED] 5.1.2e in Netherlands– positive result received on the [REDACTED] 5.1.2e
- Male experienced hay fever type symptoms whilst staying at the couples house between [REDACTED] 5.1.2e No other information available on symptoms.

At present we only have the first name and phone number of the couple and we are seeking extra information.

If you have any additional information you could provide us on this positive result, it would be much appreciated.

The information we would like is outlined below;

- 1) What test was used to determine the positive result?
- 2) If RT-PCR, what was the Ct value?
- 3) Is the case currently symptomatic?
- 4) Do you intend to re-test?
- 5) Do you intend to genome sequence the virus from the case, and if so, would it be possible for that information to be shared with us?
