Dear I-MOVE primary care influenza colleagues,

I hope you are all well in these busy times.

Some of you have asked about the deadlines for the primary care end-of-season influenza VE analysis and reports. We have just heard today from ECDC that they have accepted a postponement of the I-MOVE deliverables.

The I-MOVE annual meeting is likely to take place in September. We will send out more information as soon as we know it.

We believe it would be useful to have the end-of-season pooled VE analysis carried out by the summer, therefore we would like to ask of you to

submit your end-of-season influenza data ideally in May, but at the latest by the end of June. We would also like to ask you to submit your

end-of-season report by the end of August.

We understand very well that you are very busy these days. **Therefore please let us know if we can support you in any way with data checking, data analysis or report writing**

(or all three). **We are happy to help.**

When sending the data, it would be useful to know about any changes to data collection, such as

- changes to health care seeking behaviour (e.g. patients told not to go to GP anymore, but use telephone) and from which date
- changes in swabbing behaviour (e.g. GPs refuse to swab or swab differently, due to lack of PPE and COVID-19 fears) and from which date
- other changes to usual surveillance that we should know.

If you are doing a multiplex, and you are happy to share these information, then we will welcome also getting the results of other respiratory infections.

For those countries sequencing viruses, we would also be happy to have the data collection form on I-MOVE ID numbers and GISAID accession numbers by the end of June, if this is feasible.

If you think any of this is not feasible, please do not hesitate to let us know and we can discuss together other deadlines.
