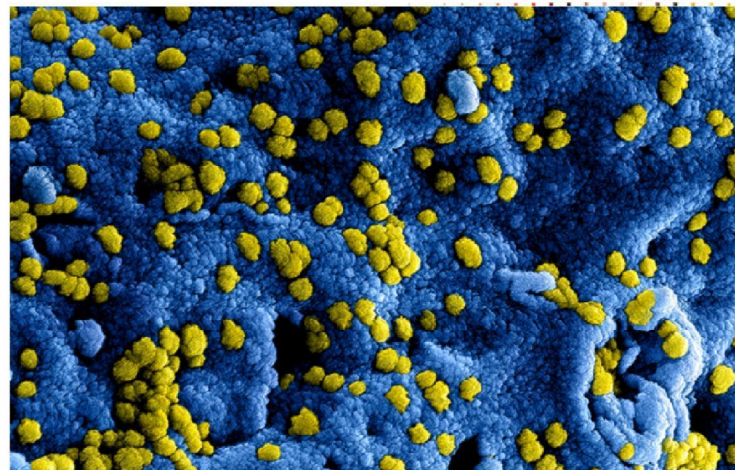

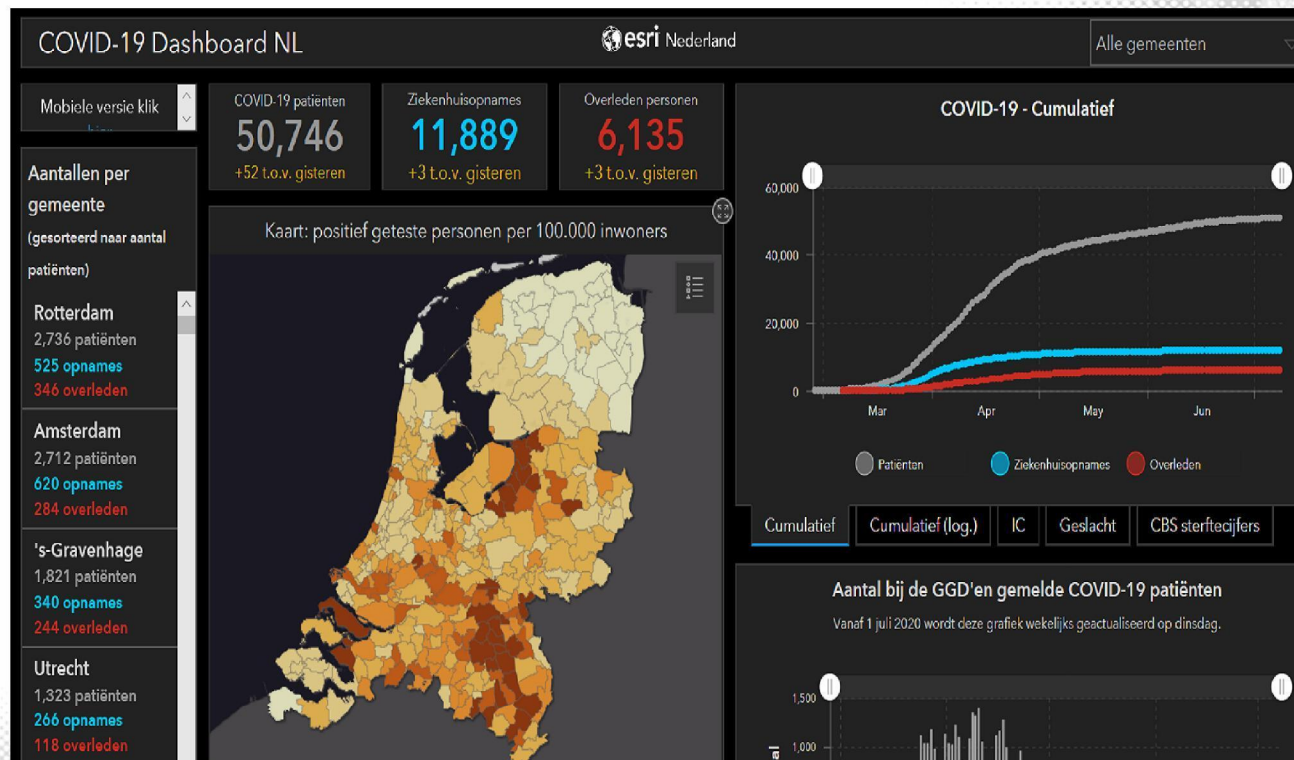

National level

- Ministry of Health, Welfare and Sports, EZ, SoZa
- Dutch Centre for Infectious Disease Control (CIb), RIVM
- WBB – Wageningen Bioveterinary Research
- Health Inspectorate (IGZ), NVWA (Food safety authority)

Regional level

- Municipal Health Services (25 GGD)
- Disaster Medicine Organization (25 GHOR)
- Hospitals, medical specialists
- (Public Health) Laboratories

Local level

- General Practitioners (9.000 GP)

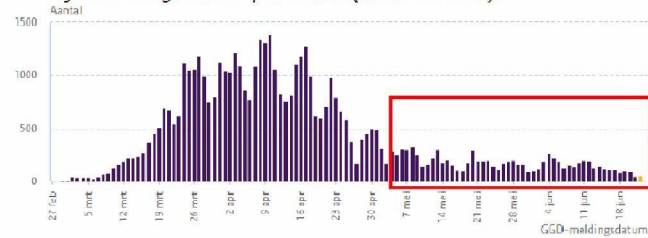

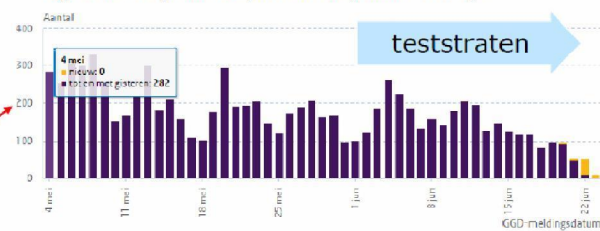
23 juni 2020 – meldingen en ziekenhuisopnames



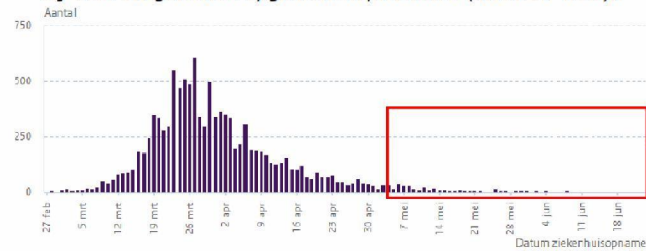
Bij GGD'en gemelde patiënten (sinds 27 febr):



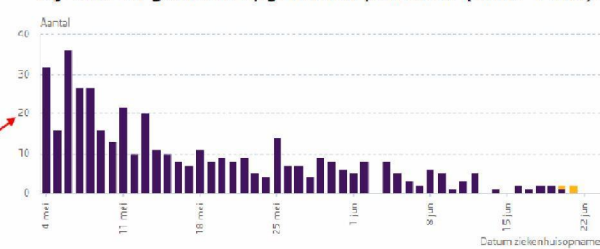
Bij GGD'en gemelde patiënten (sinds 4 mei):

Lockdown - Slow response?

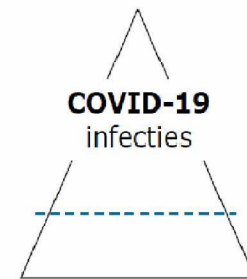
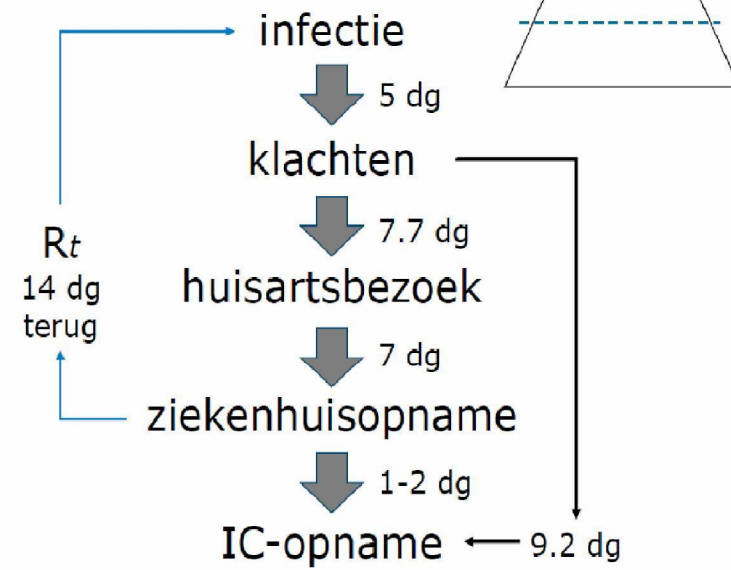
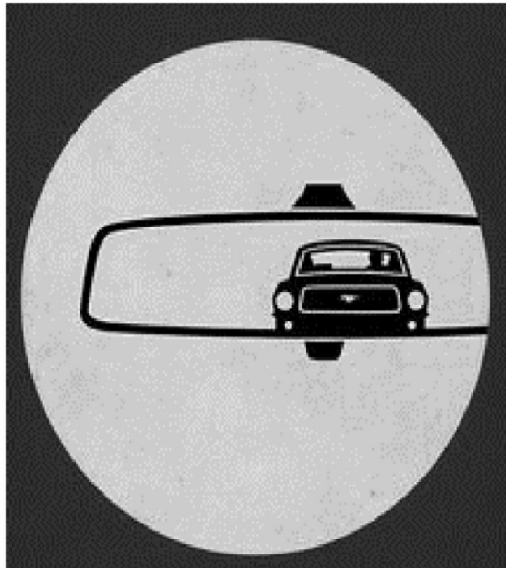
- Previous outbreaks: containment with testing, contact-tracing, isolation and quarantine
- Surprised by the explosive spread and serious clinical presentation (IC-capacity) of COVID-19
- Drivers: wintersports-holidays and Carnaval; insufficient emergency preparedness / supplies
- Outbreak Northern Italy !
- March: “intelligent” lockdown – (joined) civil responsibility
- Economic support packages – support base

Challenges:

- “100% action – on 50% knowledge”
- Preparedness: test-capacity; PPE;
- Regional differences versus generic mitigation measures
- Focus on Intensive Care capacity; less attention for the elderly in nursing homes
- International coordination: border areas (different rules)
- International migration – industrial labour
- Unattended / postponed health care

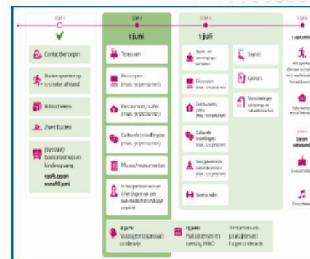

Strategy and goals:

Strategies:

- Containment of the virus
- Prevent (and contain) local outbreaks
- Vaccin development and availability

Goals:

- Protect vulnerable groups
- Maintain care system capacity
- Early warning and surveillance

Preparation 2nd wave:

- Increased surveillance (various systems)
- Test capacity national - > 30,000/day
- Sewage testing
- Behaviour monitoring

International perspective:

❑ ECDC / EC:

- positive international guidelines, information sharing (dashboard), etc.
- Challenge: coordination between countries; organizing international economic (recovery support)

❑ WHO: advocacy / support less developed countries; countries at high risk; equity (treatment and prevention)

- Evaluation pandemic management (committee established 09-07)

❑ ASEAN (*Association of Southeast Asian Nations*):

- EU bilateral trade agreements (EU – country)
- Special relations between Europe and overseas territories (e.g. Netherlands – Indonesia)

Future:

- **Early detection:** International Health Regulations
- **Impact mitigation:** strengthening health systems, economic support
- **Prevention:**
 - reorganize food industry (zoonotic introductions);
 - vaccine development and accessibility
 - Special attention to Africa
