HEALTH DECLARATION:

FOR ALL PASSENGERS AGED 13 YEARS OR OLDER TRAVELLING TO AND FROM THE NETHERLANDS A HEALTH DECLARATION IS MANDATORY BEFORE BOARDING.

PASSENGER LOCATOR DATA:

THE LOCAL HEALTH AUTHORITIES MAY REQUEST OPERATORS TO PROVIDE PASSENGER LOCATOR DATA IN A VERY SHORT TIME (INCLUDING SEAT NUMBER) FOR CONTACT TRACING. OPERATORS SHOULD THEREFORE KEEP THIS INFORMATION FOR AT LEAST 2 WEEKS AFTER EACH FLIGHT. A PASSENGER LOCATOR FORM DRAFTED IN ACCORDANCE WITH INTERNATIONAL STANDARDS CAN BE USED FOR THIS PURPOSE.
