- These passengers will have to show a verification letter from the government of Curaçao that they are allowed to travel to Curaçao;
- Medical Specialists and other medical personnel authorized by the Government of Curaçao inbound from countries not listed in Attachment I of this Security Bulletin.
  - These passengers will have to show a verification letter from the government of Curaçao that they are allowed to travel to Curaçao;
- Other persons specifically approved by the Government of Curaçao inbound from countries not listed in Attachment I of this Security Bulletin.
  - Examples are: Ship Crewmen; Persons from Curaçao who are studying abroad and who are in dire circumstances; Persons who wish to settle permanently in Curacao and who have deregistered from the civil registry of their place of residence; Persons attending a funeral; Persons in need to visit a patient (family member) in terminal phase. These passengers will have to show a verification letter from the government of Curaçao that they are allowed to travel to Curaçao. Specific conditions may apply.

— **Transit and Transfer passengers**

Flights with Transit/ Transfer passengers are not allowed, except flights with Transit passengers who remain on board of the same aircraft and Wing to Wing Transfer of passengers from one aircraft to another aircraft without entering the transit terminal. This requires strict and timely coordination with the Airport Authority and the boarding carrier. A minimum of twenty-four (24) hours prior notice is required.

Exemptions are:

- Transit and Transfer Passengers travelling from Bonaire, St. Eustatius, Saba, Aruba and St. Maarten, are allowed to disembark and enter the transit /departure hall during ground stop.

— **PASSENGER REQUIREMENTS**

The following requirements are applicable to all passengers originating from the Netherlands, bound to Curaçao.

Passengers listed in section II (A) ii. of this Security Bulletin (passengers originating from a medium risk area) shall undertake a COVID-19 PCR test at a nationally accredited laboratory as close to departure date as possible, but in any case, no earlier than 72 hours, prior to the scheduled departure date. The result of the passengers' PCR test must be submitted as soon as possible before departure to <sup>(10)(2e)</sup> @gobiernu.cw. The passenger shall also submit a hardcopy of the PCR test results at Immigration or at an indicated government agency upon arrival in Curacao. The PCR test is per person and the test is mandatory for all ages. To be permitted to board the flight, the PCR test must indicate a negative result.

Passengers listed in section II (A) i. of this Security Bulletin (passengers originating from a low risk area) are exempted from this requirement.

**(B) Public Health Passenger Locator Card**

Every individual passenger shall complete and sign the Curaçao Public Health Passenger Locator Card (PLC). This PLC must be submitted by e-mail to: <sup>(10)(2e)</sup> @gobiernu.cw, no earlier than 48 hours before the flight. The passenger shall also submit a hardcopy of the signed form at Immigration or at another indicated government agency upon arrival in Curacao. The PLC form is available for download on the government's website: <http://www.gobiernu.cw> and on the CCAA website: <http://www.ccaa.cw/>.

**— REFUSAL TO BOARD**

Those passengers not being able to demonstrate a negative COVID-19 PCR test outcome shall not be permitted to board any flight bound to Curaçao.

**— QUARANTINE REQUIREMENTS**

Mandatory quarantine of 14 days at a separate location in Curaçao, including a COVID-19 PCR test may be the result of health screening and questioning performed by the Department of Health of the Government of Curaçao upon arrival, depending if:

- The passenger has been present in a COVID-19 high risk country with widespread infections in the previous 14 days of attempted entry (any other area than listed in Attachment I); or

- The passenger shows COVID-19 related symptoms upon arrival; or
- The passenger has been in contact with anyone that was diagnosed COVID-19 positive, in the previous 14 days of attempted entry.

**— CREWMEMBER REQUIREMENTS**

Crewmembers are exempted from all measures as laid down in this Security Bulletin shall be allowed to continue with their duties while complying with the sanitary rules applied by the Government of Curaçao, to include but not limited to, wearing a face mask before disembarking, social distancing, etc. This includes a compulsory quarantine during stayover.

Depending on unforeseen circumstances, the duration of the quarantine may be extended to a period of maximum 14 days.
