What are the consequences of this crisis for International mobility and migration?

Under-detection of COVID-19 infection and migration of vulnerable health-impaired migrants pose a risk to management in the Central Mediterranean region. Due to war and difficult conditions, including lock-down, little information is available about infections and displacements. This undermines the control of COVID-19. It poses a risk to migrant health and spread to European destination regions. Open real-time data on (suspected) incidence of COVID-19 infection among migrants, and their movements.

What Does COVID19 Mean for Vulnerable Groups, Including Stateless Persons?

Will globalization be more strictly regulated?

Reducing the chance of a virus or bacterium leaping from an animal to humans, thereby reducing the number of zoonoses expected to only increase in the coming years - better protection of nature, stricter approach to catching / hunting / poaching wildlife trafficking, and reducing the number of potential hosts for a virus or bacterial infection by radically reducing livestock increasing the distance between places where animals are kept and where people live.
