Regarding to your questions on COVID-19 topics, we have answered the questions below.

### **COVID-19 and effects of closing schools**

In general:

- Since 15th of October the [inspectorate of education](#) monitor which [schools are closing](#).
- Schools are responsible to administrate on the website when the school closes. The inspectorate will contact the board or school for solutions and other the consequences related to the closing of the school.

- When schools are closing, schools organize online education.
- Mostly, the schools close for about 2 weeks.

Effects:

- Social partners address learning disadvantages of children, not only because of the closing of school in October/ November but also during the spring.
- We don't have results of monitors on learning disadvantages.
- Because we need to make decisions on the central exams in our secondary education in a few weeks, a short questionnaire went to schools for pre-vocational education.
- Possible effects on economy: for parents with children at home (during school closing) couldn't work full time.

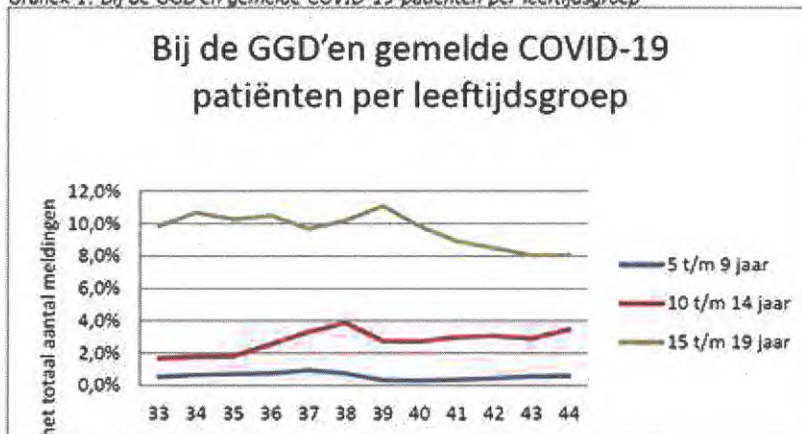
**Studies on the role of children or the role of schools regarding to the spread of COVID-19**

- The National Institute of Public Health and Environment (RIVM)
  - indicates that infected children and their infectivity increases with the age of the children. At the same time, the role of children in spreading the virus is less than adults.
  - Indicates that the spread of COVID-19 mostly happens outside school area in contact with classmates in their own time.

**Specific information on age groups of 6-10 and 10-14/15**

- We have some specific information on infected age group of 10-14/15 (see below; only available in Dutch). This is the most recent data of our National Institute of Public Health and Environment (RIVM). I would like to emphasize that the data is confidential.
- The government strongly advises to follow the numbers and guidelines of the National Institute of Public Health and Environment (RIVM).
