Dear OPC Colleagues,

As mentioned during today's meeting, I am attaching detailed information about items which would be included in a "notional" stockpile of medical equipment related to COVID Wave 2 planning. This is a work in progress, but I thought it might be useful to you as you consider the stockpile and trust fund. In the end, we will use it to orient Allies' consideration of in-kind contributions to the stockpile and for targeted purchases to fill the gap between the notional stockpile and in-kind contributions.

It was designed by a team of medical experts led by Lt Col Siebren Wolf (NLD), the EADRCC's Medical Advisor. They based their work on recent medical experience during the COVID crisis, WHO COVID-19 guidelines, and other credible sources. Col Gerald Rots, the NATO Medical Advisor, is now reviewing and revising the plan and will soon share it with the larger NATO medical community. In short, the design provides the following capabilities:

- Support for 100 Intensive Care Unit (ICU) beds and 400 Ward beds (including support equipment, pharmaceuticals and consumables). This can be split for use in multiple locations, or scaled up/down.
- Personal Protective Equipment for a regular ICU and Ward staff of doctors and nurses
- Supplies that provide 14 days of operations, plus 10% surplus
