Thank you very much for sharing the questions beforehand. And as said I do have some surprising news to bring to the table:

Question 2 *How and what digital technologies has been deployed in (Your Country) to fight and control the epidemic?*

The Netherlands decided to hold an *open, participatory* scrutiny & selection of the Track & Trace app. They organized an #appathon where 7 selected app-providers were questioned and challenged..in public. It was streamed via YouTube; citizens, journalists, coders, doctors, psychologists send in their questions and could see how the app-developers tried to answer it. The contestants (ia Accenture, CapGemini, ITO and others) all presented their solution to the Dutch public:

As far as we know the only other country that made an open co-creation of the Track & Trace app is Taiwan, under the leadership of the Minister of Digitalization Audrey Tang.

The government gathered all the lessons learned during this appathon and is working on the development of several digital support tools. In the meanwhile citizens are sharing health information with 2 apps developed by hospitals -on a voluntary basis.

Suggestion for the follow-up question : *such a open process for the selection of an app is indeed unique-certainly the only example in Europe. Can you share some results?*

Yes (10)(2e) absolutely.

(1)The first result is that Dutch citizens dived into the codes and revealed a **fault** in one of the apps. It was actually heartwarming to see a huge amount of people willing to sacrifice their free weekend to collectively reflect about the quality of the proposed apps.

(2) Secondly it helped crystallize **the criteria for the use (and trust) of an app**. Politicians, scientist and citizens engaged in a vivid online debate (through twitter and youtube and facebook) decided that the app should be open-source, the codes published on Github, on a voluntary base and with strong data-ownership. And since public trust is key this is extremely important.

(3) Thirdly: strengthened **public-private partnerships** in fighting covid-19. Large amount of initiatives from the private sector (including #Techleap, #TechTegenCorona, #wesupporthospitals) that are welcomed by the government. And government bending backwards to support tech through special programmes (RVO, Innovation Quarter, ministries) etc.
