The objective of the course is to support personnel at competent health authorities in EUMS to perform focused inspections on board cruise ships and ashore facilities, to review procedures and plans in order to ensure measures mentioned in the "Interim advice for restarting cruise ship operations after lifting restrictive measures in response to the COVID-19 pandemic" are met both by cruise ship operators and port authority.

Recorded Webinar

Exercises/short assignments

Objective

Test

After the completion of the recorded webinar and the exercises/short assignments there will be a test.

It will include multiple choice questions covering the topics discussed in the pre-recorded webinar.

Objective

It is a tool to evaluate the degree that the learning objectives have been achieved. It will include multiple choice and short answer questions covering the topics discussed in the recorded webinar.

Duration

You will have a strict **1-hour** to complete the test, and there will be a timer in view on your screen. You must complete the test and click the submit button within the 1-hour window.

You will be allowed to make **five attempts**.

Results

The test will be graded. You will receive your marks immediately after completion of the test (clicking the submit button) and you will be able to review the correct answers. You will need to answer 80% of the questions correctly in order to pass the test.

Course Evaluation
