The European Commission plans to publish its pharmaceutical strategy roadmap on March 11, according to a Commission official.

The pharma strategy roadmap will follow the Commission's release of its industrial strategy, which should be [published on March 10](#).

The Commission plans to lay out its pharma strategy in a communication [by the end of 2020](#). In leaked documents seen by POLITICO in January, the Commission said it wants to [tailor incentives to patients' needs](#).

The Commission [also plans to publish](#) a review of the orphan and pediatric drug regulations at the end of the first quarter of 2020.
