Please find the word document I made for my ambassador to share with the new Coronavirus envoy in the Netherlands.

I found the massive testing could be possible because of a lot of unique Korean things such as municipal healthcare facilities all around the nation, which is now converted to sampling facilities. More than 100 labs to test the virus with proper equipment and facility because of the lesson learned during MERS outbreak in 2015. This was also possible by available labors like public doctors who serves 3 years term as a military service and civil servants. Korean medical system has been also forcing doctors to see more patients in "peace times" as well due to strictly controlled medical bills by the public health insurance system. More part of medical services were insured so hospitals had to find way to make more profit such as "labs"

I heard the Netherlands will perform more testing from my diplomat colleagues. However, it needs labs/instruments and trained labor which cannot be obtained in short time. So we can think of interim solution like Finland which is sending its samples via airplane to Korea to test.

I also send you the updated version of testkit supplier list from KOTRA this morning including some rapid testing kits (antigen/antibody test) approved for export. Note that Korean government is still not using the antigen/antibody testing.
