With reference to email from (10)(2e) (10)(2e) [REDACTED] (10)(2e), we are pleased to submit our Proposals for the supply of Personal Protective Equipments (PPEs) of Medical Disposable Protective Suit (Insulation Jacket), Protective Goggles, and three types of masks, KN95 (N95), KN95 (N95) with CE and Disposable Surgical Masks as attached. (I will send 3 separate mails for your convenience)

Korea prohibits exporting of Protective Suits and Masks, so we are supplying them from China and Vietnam.

We will airfreight the consignments from Beijing, Guangzhou airport in China, and Hochiminh airport in Vietnam where KLM is available, and supply on weekly basis and FOB basis.

The payment should be 50% of each shipment amount in advance on ordering and 50% balance just before each shipment. However Contract shall be for whole quantities. First delivery will be 10 days after initial payment.

We will supply Protective Suit with CE certification from China, and without CE certification from Vietnam. We are supplying Vietnamese Protective Suit to (10)(2e) [REDACTED] (Korean subsidiary of (10)(2e) [REDACTED]) for Korean market with Korean Certification.

Our offers will be valid untill close of coming Friday (March 27) in European time.

We will be looking forward to receiving your reply within March 27, Friday.
