Through the Dutch Trade Association MODINT I have received the request to look for production companies that can produce Personal Protective Equipement for hospitals.

For the moment they are especially interested in Surgical Gowns.

We are looking for products that are comparable with Mölnlycke 19055 and 19255.
The product **must at least** meet the following specifications;

- a. **Product** Isolation Gown with Sleeve Cuffs, neck- and back-ties, non-sterile, water repellent, latex-free.
- b. **Length** Approximately 127cm
- c. **Sizes** Large and ExtraLarge (L and XL)
- d. **Main material:** Polypropylene Spunbond, nonwoven => 28 gram/m², or
Spunbound/Meltblown/Spunbound (SMS) => 23 gram/m². Color Blue or Yellow

Normally these products need a (10)(2e) conform EU directive (89/686/EEG) and need to provide protection conform NEN-EN 14126 (3B).

It is not yet definitively decided whether a CE certificate/Document of Conformity and Test Reports is required but I would like you to inform me in this phase already whether these documents are available.

Indicated demand; min 100.000 per week, during coming 12 weeks.
