On your question on restrictions for PPE export from Vietnam: So far export restriction is applied only on medical facemasks.

According to the Resolution 20/NQ-CP dated 28 Feb 2020, during the effort to prevent and control COVID-19 infection the Vietnam Ministry of Health will only license export of medical facemasks as international aid or assistance from the Government of Vietnam. Up to 25% of production may be exported; 75% of production shall be used for epidemic control within the country. This does not apply to export of export processing enterprises that have been granted the certificate of investment registration and enterprises processing medical facemasks under processing contracts with foreign traders concluded before March 01, 2020.
