Subject: Following up on our priority request

Dear all,

in the past few weeks two colleagues of ours, (10)(2e) and (10)(2e) from the Ministry of Economic Affairs and Climate Policy (EZK) asked for your help to identify suppliers of personal protection equipment (PPE) in your countries, more specific: gloves and gowns.

Many thanks to you, for the leads and background information you gave us. We got enthusiastic reactions from you.

Besides concrete leads to suppliers and matchmaking assistance, we also got information about the present situation regarding trade restrictions. Both types of information are very valuable.

EZK forwarded all information to the Trade department of the Landelijk Consortium Hulpmiddelen (LCH; the central purchasing organization for PPE on behalf of our ministry of Health). Based on this information, combined with the needs in the Netherlands, they contact the suppliers and make deals. In a few cases we could see that your contribution helped in making a deal. In other cases it is possible that a deal will be closed in the near future.

EZK made a small overview of the countries which gave us information, and combined this with the information we got back from LCH. It is possible that the this list is not completely accurate, amongst others because of the time pressure in this crisis situation.

Gloves:

Info supplied by:

- Morocco: due to trade-restrictions on hold by LCH
- Hong Kong: -> picked up by LCH, in progress
- South Korea -> contacted by LCH, but no match due to quality standards
- Vietnam -> picked up by LCH, ongoing
- Malaysia -> picked up by LCH, deal of 15 Million gloves, will be followed by other large deals; embassy is very involved on a daily basis
- Turkey: trade restrictions, no actions at the moment

Gowns

Info supplied by:

- Moldova: in progress
- Poland -> picked up by LCH, contacted, not leading to a deal because of export-restrictions
- Turkey: trade restrictions, no actions at the moment
- North Macedonia -> picked up by trade; via Dutch company called (10)(1c), setting up an new production line.
