Our Team Leads working with CMC have observed failure in hospital administration and staff to prepare (training, protocols for treatment, restricted access, PPE, screening) for country opening and a potential COVID-19 outbreak. AMI team leads in Curacao continue to recommend COVID management protocol, PPE procedures, admissions and flow to projected COVID wards. Currently three separate wards for COVID treatment in CMC which are not collocated, and require transport through active main corridors. CMC does not restrict access to staff, family and patients. AMI continues to advocate for the Old Hospital to better manage a possible influx of COVID positive patients.
