New NOTAM available

Today, the Ministry of Justice and Security has issued a NOTAM in regards to the July 1st update on COVID-19 travel restrictions.

Please be aware that the new regulations state (also in the NOTAM) that the health declaration is now mandatory for all passengers (departing, transferring and arriving) from 13 years of age.

In addition to the recommendations from the Council of the European Union, the government in the Netherlands has issued an additional provision for passengers travelling from the United Kingdom and Sweden:

Passengers from the UK and Sweden, are urgently advised to observe a 14-day self-quarantine, with exemption of the travellers mentioned in the enclosed NOTAM under I-VIII.

Furthermore, we are informed that an instruction from the Ministry of Health, Welfare and Sport has been issued to the Mayor of Haarlemmermeer (county where Schiphol is located), providing regulations and instructions in regards to enforcement and supervision of the mandatory health declaration, 1,5 social distancing rule and the mandatory use of mouth masks at Schiphol. We will inform you accordingly when we receive information on the implications of this instruction from the Mayor of Haarlemmermeer, in her role as chair of the Safety & Security region of Kennemerland (region where Schiphol is located).
