With many apologies for the delay in coming back to you due to preparations for the UNGA ACT A event today.

The reason for the requested call with CEPI is to discuss possible collaboration with the Dutch government on a candidate COVID-19 vaccine by a Multi-National Corporation that would be manufactured in the Netherlands. The information is commercially confidential so I am only able to provide a high level overview below, but we are happy to provide more details in confidence during a call.

There is an opportunity to negotiate with the company that doses of the vaccine could be secured for both the COVAX Facility and the EU Pooled mechanism (we are also discussing this with the EC) so there are also direct benefits to the Dutch population.

I hope that you and relevant colleagues may be available for a call this week or early next week with myself and CEPI (b) (6) (b) (7)(C), to explore possible collaboration.
