Description EpiShuttle

- EpiShuttle is a single- patient mobile isolation unit, utilized for the transportation and temporary isolation of patients with highly infectious diseases
- The EpiShuttle offers various safe treatment capabilities during patient transport
- With vacuum pressure mode, the EpiShuttle protects the environment from contamination of highly infectious diseases from an infected patient
- The overpressure mode of the EpiShuttle protects an immuno-suppressed patient from the contaminated environment
- Through battery power the unit is operable for a 24h timespan
- The EpiShuttle is equipped with several access ports allowing for ICU treatment of the patient , among other, vital function monitoring, the administration of i.v medication and volume, oxygen supply or mechanical ventilation during entire mission
- The unit is compatible with our Challenger 604

Upon confirmation from the client

- **Consent form to be signed by patient / family and returned to operator**
Please send Air Alliance the signed consent form prior to mission commencement
- **Organization of Hospital Admission at Destination (Isolation)**
Please provide Air Alliance with a written confirmation of the admitting hospital that patient will have a bed in the isolation ward.
- **Ground ambulance organization**
If agreed upon with the client, Air Alliance will organize ground ambulances; if client organizes ground ambulances, Stryker stretchers on the ground ambulance are preferred.
- **Disclosure of the infectious transport arrival to the proper administrations and authorities at destination**
Client needs to inform the authorities at destination about the patient entering the country, carrying a notifiable infectious disease.
- **Preflight preparations of patients by hospital at patient location**
 - insertion of bladder catheter
 - body wash and dressing of patient in hospital clothes, front open
 - Diaper , insertion of 3 i.v accesses
 - preparation and supply of all necessary medication oral& i.v for the next 24h
 - preparation and supply of all medical information
- **Travel documents**
If applicable, client is responsible for a valid visa. A copy needs to be sent to the operations control center prior to the mission.
Patient's passport incl. visa must be handed over to the medical crew.
