In het debat van 8 april jl. heb ik laten weten dat er breder vanuit de EU geïnvesteerd wordt in de ontwikkeling van een vaccin tegen COVID-19. Uw Kamer heeft mij gevraagd dit in deze brief nader toe te lichten. U bent eerder geïnformeerd over de bijdrage van Nederland aan vaccinonderzoek via de *Coalition on Epidemic Preparedness Innovations* (CEPI), een innovatief wereldwijd partnerschap tussen openbare, particuliere, filantropische en maatschappelijke organisaties. Inmiddels kan ik u melden dat Nederland hier €50 miljoen aan bij zal dragen.

Ook via de Europese Commissie (EC) draagt Nederland indirect bij aan vaccinontwikkeling. De EC heeft de volgende bedragen beschikbaar gesteld:

- €93,5 miljoen investering in vaccinonderzoek vanuit het Horizon 2020 programma, dit gaat buiten CEPI om. Het gaat om een

call van €48,5 miljoen. voor 18 projecten waarbij voor 9 projecten Nederlandse partijen mee doen. Daarnaast heeft de EC €45 miljoen bijgedragen aan het Innovative Medicines Initiative, waarbij ook €45 miljoen wordt verwacht van de industrie.

- €80 miljoen voor een lening aan CureVac, een biofarmaceutisch bedrijf¹¹;
- €50 miljoen reguliere bijdragen aan CEPI in 2020.

As per our call yesterday, I am sending you some additional information:

1. To join CEPI and to make a contribution we have two types of agreements. One for investing into the common pool and becoming a member of the Investors Council – this document is called the Bilateral Investors Agreement and attached here. For new donors who want to invest specifically for Covid-19, we have developed a simpler Grant Agreement letter – also attached to this email. Should Netherlands chose to split the funding and contribute to both funding streams in order to be part of the Investors Council, then the Bilateral Investors Agreement would be the document we use to regulate the relationship.

3. During our call we spoke about you reaching out to Germany and UK as two of our large investors. Let me know if you also would like to talk to the Norwegian Government. I can set up a dialogue for you with the Norwegian Ambassador to the Hague or connect you with one of our main contact persons in the Norwegian government in Oslo. For Germany, as mentioned during our call, the funding to CEPI is allocated from the Ministry of Research and Education. Our main contact person, and who is also currently chairing the CEPI Investors Council, is Dr. Joachim Klein who Heads the Division of Global and Public Health Research within the Ministry of Research and Education. 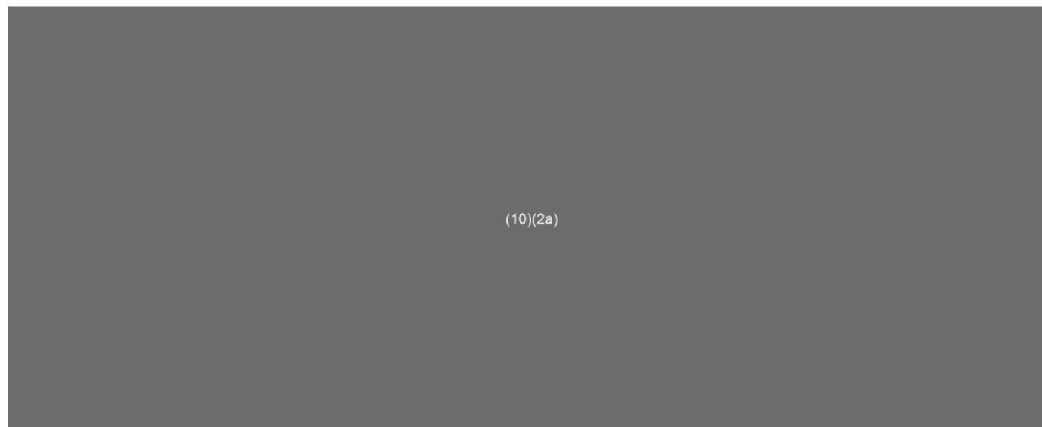

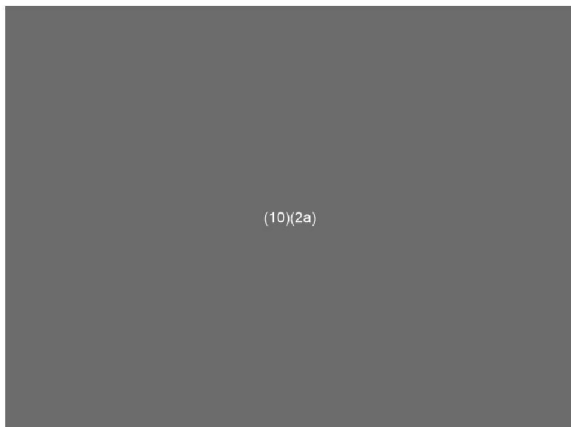
