Onderwerp: BSN moves to temporary remote learning

Dear [redacted] and [redacted],

We were given your contact details by the International Hague Centre. We would like to inform you that the British School in the Netherlands today informed its parents that we would move to temporary remote learning until the Easter Holidays (so the first day back would be Monday 20th April).

The decision to temporary move to remote learning is certainly not one that we have taken lightly. However, we have taken into account the needs of our international community and taken this precautionary measure to ensure the health and wellbeing of our students and staff.

We have not had any confirmed cases of the Coronavirus.

Closure will take effect from Tuesday 17th March onwards. Monday 16th March will be used as a transitional day. Schools will run a normal timetabled day on Monday to help teachers and students prepare for closure.

We feel that given the current uncertainty and anxiety within the international community, this is the most prudent decision to take for the health and wellbeing of everyone.

Could you let us know if there is anyone further we need to inform about this? Don't hesitate to let me know if there is further information that I can provide at this stage.
