

## MEDEVAC ACTIVATION PROTOCOL CAS-BES

### AIR AMBULANCE

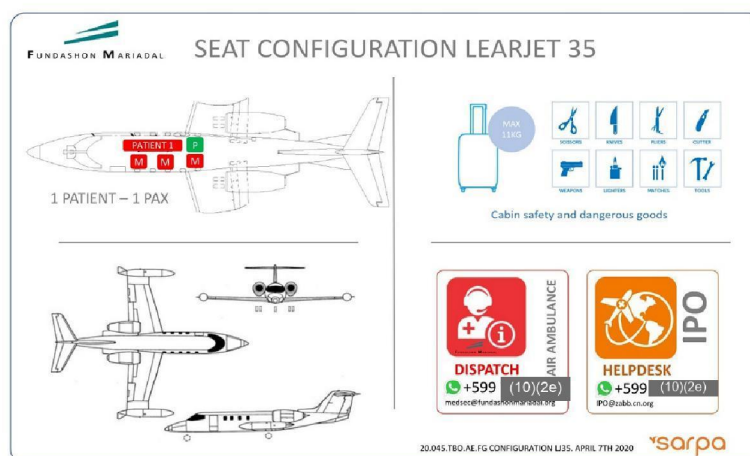
#### 1. Context

FM-SARPA transports both non-COVID19 and COVID19 patients during the coronavirus pandemic, and transport of high-risk patients (high risk pregnancy, oncology, neonatology).

- 1.1. A non-COVID19 and COVID19 medevac, and/or- medical charter is activated via the 24/7 Dispatch call center, phone +599 (10)(2e) email (10)(2e) @fundashonmariadal.org.

*Note: A medevac is only accepted if treating and receiving medical specialist have approval of admittance of the patient.*

- 1.2. Air Ambulance flight doctor (anesthesiologist) on call, contacts treating medical specialist /physician and performs medevac intake.  
 1.3. FM-dispatch initiates medevac request.  
 1.4. Medsec coordinates logistics with receiving hospital/Insurer (10)(2a) and ground ambulance.



2. Notifications Governments/Insurers Due to COVID19 regulations and mandatory Government approval, additional procedures are in place for the countries (10)(2a) (10)(2a). Notification of an Air ambulance is initiated by the FM dispatch center.
