Dear all,

It has taken a long time, apologies for not sending updates earlier. We started off testing the app with a small group within AMIGO and then went bigger. At each step, there were things to solve to make the system easier accessible, which is why it took so long to send this update. The good news is that things now run, including the webversion.

I attach two documents: An excel file that has all latest questionnaire items as well as the notification texts. Regarding the questions, only in the monthly questionnaire (2) did we adapt item (10)(2e) and (10)(2e) as compared to the version from 28 July.

I also attach the Amigo invitation letter, in case you'd like to send something similar.

All texts and the logo will be cohort specific, meaning that each cohort needs to check and adapt the respective texts.

Subject: IMPACT - next update

Dear all,

it has been some time since the last update. Essentially, we have worked very hard on all kind of safety issues around the app. We have done that together with our digital data safety officer from UU and YRA. Right now YRA has asked an independent company to perform a pentest ("hacker test"), of which we are expecting the results any day now. We have also tested a first version of the app, and very slightly revised some of the questions (nothing major). MedLaw (EB van Veen) has provided feedback on the disclaimer and we adapted that as well.

We have also decided that for the moment being, it would not be relevant to ask for daily symptoms, and we have changed the settings in the app accordingly.

These are the things that still need to happen before we can go live:

- test a second version of the app
- receive the results of the pentest
- receive some kind of reaction of the FG on our second version of the DPIA (hopefully all positive...)
- put information on the YRA website, primarily pertaining to installation instructions.

I honestly hope we can start now very soon.

All material is attached to this email. Please let me know if you need anything else, or if things are unclear.
