Following an update on joint procurements at the Health Security Committee meeting yesterday, we are happy to share the latest status with you in the following link :

Moreover, we would like to thank all countries for their timely replies in scope of the latest consultation on a joint procurement of antigen tests.

Currently, we have received 22 replies from signatories of the Joint Procurement Agreement (JPA), namely:

- 17 countries have expressed interest and submitted their needs
- 2 countries are considering/need more time to compile the needs
- 2 countries have declined interest
- 1 country is interest in other laboratory equipment, but not antigen tests.

We are currently analysing the procurement needs and plan to share the first draft of tender specifications with the participating countries within coming days. The first meeting of the Specific Procurement Procedure Steering Committee (SPPSC) on the key features of procurement approach and documents will be scheduled shortly. (NB: Only the appointed SPPSC members and alternates will be granted access to draft procurement documents and invited to take part in the follow-up meetings on this specific procurement.)

Lastly, we would like to inform you that the joint procurement procedure above will be preceded by procurement of antigen tests using ESI funds, as recently [announced by President Von den Leven](#).

We are looking forward to receiving your insights on how the afore-mentioned actions could best support your national testing strategies.
