

We have two general remarks to add. We have some small suggestions already on a couple of paragraphs between square brackets, but in general we have no final positions on these matters yet, because we are still waiting for the communications of the commission. We are hoping we will still have enough time to discuss/respond on these paragraphs after studying the expected proposals.

The second general remark is regarding the aim of the council conclusions. We would like to strive towards wording that is specific and clear for everyone instead of open to multiple interpretations. This is why we have added some requests to clarify the paragraphs a bit with additional wordings.
