Er wordt nog steeds serieus gesproken over N95 mondkapjes als interim/stop-gap oplossing, wat zeer positief is voor NL. Zaak is om nu geen verwarring te zaaien. Ik zou de Weihton machine ASAP bestellen (als dat niet al gebeurd is) en afspreken dat er een tweede machine (TTRI of Weihton) besteld gaat worden als de pros/cons duidelijk zijn, maar in ieder geval binnen 10-14 dgn oid.

Onze man 10.2.e is goed ingevoerd bij de MOEA en zijn constatering tav de link tussen machines en tussentijdse levering van mondkapjes (in geel) lijkt me een duidelijke hint; jij noemde dat de "package deal"

Het JV verhaal is gezien jouw feedback afgezwakt, maar mogelijk aan Taiwanese kant nog niet helemaal van tafel.

TTRI is the national team comprised of many elite small and medium size manufacturers as a project team, plus the ties with MOEA which controls mouth caps and MB PP fabric.

Dear All,

Just spoke to MOEA Minister Shen: overall supportive of the broader cooperation between Taiwan and the Netherlands. They are also very keen on the Philips ventilator production line. Agreed to meet soon (aiming at next week) in person to discuss/finalize. Raised as well the urgency of delivery of the equipment and will do that again when meeting with him and team. Will try to be included in the overall cooperation agreement, although the Taiwan manufacturer (weiton) will probably want to have control over the timing.

For the confirmation of the N95 mask supply, Taiwan MOFA is preparing a draft agreement for the cooperation – incl mask supply, equipment procurement – between Taiwan and the Netherlands. This agreement will need to be approved by the COVID-19 Central Command center to allow the export of N95. Hope to receive today, and keep you informed.
